Fall 2014 Board Talking Points

Education & Operations

- The Centers for Disease Control and Prevention (CDC) has posted Interim Guidance for Emergency Medical Services (EMS) Systems and 9-1-1 Public Safety Answering Points (PSAPs) for Management of Patients with Known or Suspected Ebola Virus Disease in the United States online at the CDC website.
- Hearing Standards for Public Safety Telecommunicators released in June
 - The document defines standard hearing requirements and audiology necessary to perform the basic functions of the telecommunicator position and includes information relative to telecommunicator position requirements, audiometric testing of candidates & employees, audiology, and Americans with Disabilities Act as it relates to employment.
- The collection of associations and interested parties working on national training guidelines is moving forward. The group is nearing consensus of the topic areas that would be a part of the guideline and will be turning its focus to the development of a legislative packet to assist interested parties to push for legislation / requirements in their respective states.

- The Quality Assurance joint standard developed by both NENA and APCO will be out very soon. Currently the committee is resolving public comment.
- A number of documents are nearing completion and work on revising a number of operational documents has recently begun. I would encourage anyone interested in helping with the development or revision of documents to visit the website to find something that peaks their interest.

Government Affairs

- NENA continues to pursue improvements in wireless location accuracy. We are working
 closely with the carriers to realize a long-term vision of getting a dispatchable, civic
 address for wireless consumers who call 9-1-1. At the same time, we are insisting on
 short- and intermediate-term improvements in the X/Y/Z/U capabilities of consumer
 devices and networks.
- 9-1-1 Goes to Washington has been moved to the end of February. This will ensure our continued ability to offer reasonably-priced hotel space with good transportation options, and reduce the possibility that our timing could catch Congress out-of-town.
- NENA anticipates that the FCC will take up Non-Service Initialized (NSI) phones in a rulemaking proceeding in late 2014 or early 2015. We will advise further when we have more details.
- NENA will be working with the National 9-1-1 Office, the NG9-1-1 Institute, and the
 Congressional Next Gen 9-1-1 Caucus to appropriately mark the 10th anniversary of the
 Office's creation between December and February. If you have stories or examples of

Tech

- NENA Releases "Requirements for a National Forest Guide" Information Document
 - The purpose of the document is to gather a set of requirements for a national, authoritative Forest Guide (FG) in order to allow an entity (NENA, FCC, DOT, etc.) to procure the technology and services required from this NG9-1-1 functional element.
- I3 v2 (NG9-1-1 architecture) is in final comments resolution, estimated to be complete by end of September. V3 will start in Oct/Nov with a new WG lead.
- More development activity around NG9-1-1 Core Services and PSAP operations aspects initiated and a major focus of the next X months.
- There is gradually growing recognition of and interest in use of the NENA PSAP Registry by commercial call centers.
- We are doing increasing work on NG9-1-1 cybersecurity and related topics, including the PSAP Credentialing Authority development.
- Work on Mobile Apps into NG9-1-1 including making the app developers aware of what is involved, what the NG9-1-1 core services operational processes are or need to be, how data during a 9-1-1 call would be handled at the PSAPs, how additional data during,

after, or independent of a live 9-1-1 call needs to be managed, what mechanisms might apply, education work for a number of stakeholders, and several others

ENP Certification

- Primary activities of the NENA Institute Board for 2015 will focus on increasing the number of ENPs who re-certify each year and the development of a strategic plan for the ENP Certification Program.
- There are 60 ENP candidates who will sit for the ENP Examination in the October window.

Support of NHTSA's National 911 Program

- We recently completed a White Paper on FirstNet and NG9-1-1 recommended that State 9-1-1 Offices fully participate in the upcoming FirstNet state consultation meetings, and to be actively engaged with the FirstNet Regional Offices.
- Assist in preparing the 2013 National Progress Report whereby states submit information on status of 9-1-1 and efforts toward NG9-1-1 implementation.

Next Generation Partner Program

- We have restructured the NGPP with a Steering Committee and Subcommittees for effectively managing the activities of the Program.
- New areas of focus for the NGPP include certification of products and accreditation of 9-1-1 Authorities, and cybersecurity related to 9-1-1.
